Step 3 : Hazard Assessment & risk

Hazard 1 : Equipment failure

Nature of Hazard : Equipment failure - Rifle may fail to operate properly

Persons at risk : Shooters & instructors

Control measures :

Regularly inspect rifles for signs of wear & Tear. Replace any rifle deemed unsafe.

Clean rifles after every use & regularly oil all working parts.

Rifles to be stored correctly in the gun cabinet & separately from the ammunition

Air rifle cleaning kit to always be available to clean rifles after use.

Hazard 2 : Risk of rebound

Nature of Hazard : Possibility of a pellet rebounding from target area & hitting shooterPersons at Risk : Shooters & InstructorsControl measures :Shooting position must be at the acceptable minimum safe distance from target faceThe range has been strenuously tested for rebound & deemed to be acceptableThe backstop must be inspected regularly for wear & tear.Pellet catchers must be cleaned out regularlyShooters & instructors must wear safety glasses.

Hazard 3 : Shooting control

Nature of Hazard : Inadequate control of shooters may result in personal injury to a shooter					
or instructor.					
Persons at risk : Shooters & Instructors					
Control measures :					
Shooting must always be carried out under the control of an NSRA qualified instructor					
All shooters must understand & accept this person is in charge					
All shooters must obey the rifle range rules & the commands of the NSRA instructor					
Fooling around will NOT be tolerated & will lead to dismissal from the range					
Prior safety talk & commands instruction to be given to all shooters					
No spectators are allowed in the range during shooting					
A maximum of three shooters may use the range at any one time.

Hazard 4 : Range layout

Nature of Hazard : Incorrect range layout may result in person injury to shooters
& instructors.
Persons at risk : Shooters & instructors
Control measures :
The range must be secure & laid out in accordance with Scout P.O.R.
No shooting must take place until this is the case
The range must be regularly inspected for compliance
Due to limited room, only shooters & Instructors are permitted – No spectators.
The backstop & other critical areas of the range layout must be inspected regularly.
The roller shutter door power must be isolated during use of the range, making it impossible
to open the door from the outside.

Nature of Hazard : Uncontrolled procedure leading to personal Injury Persons at risk : Shooters Control measures : No person is to cross the firing line unless instructed by a range officer All shooting must be completed All rifles must be unloaded & broken & laid down on the shooting bench. Shooters must wait until the all clear has been given to retrieve targets No shooting must recommence until new targets have been positioned & all shooters are back on the safe side of the firing line.
